III. PERIOD OF CONTRACT APPOINTMENT:

- 1. The tenure of contract appointment will be 3 years.
- 2. The contract of appointment may be terminated by either side giving 3 months' notice or by paying the contractual remuneration of three months in lieu of notice period, if the circumstances so warrant.

IV. CONDITIONS:
